About this consultation

In response to public pressure Ofgem agreed a moratorium with suppliers on the practice of involuntary prepayment meter (PPM) installations (commonly referred to as forced PPM install

Ofgem is unwilling or unable to stop the practice of force fitting PPMs then the Government must step in to put an end to it itself.

Prepay customers are often some of the most vulnerable to the impacts of living in a cold home. While 10.5% of people paying for their electricity by Direct Debit are in fuel poverty the figure for PPM users
